Plenary Session 3 – Early Intervention, Deflection, and Diversion: From the Public Health System to Intercepts 0 (Community Services) and 1 (Law Enforcement) – Pine Crest B

Using the Sequential Intercept Model (SIM) as a framework, this multidisciplinary panel will share practical solutions and evidence-based practices pre-arrest in the public health system and communities in the Mid-West Region, including law enforcement options, the continuum of crisis services, and involving civil commitment practices and assisted outpatient treatment. Early intervention with and diversion from the criminal justice system are the preferred strategies for as many persons with serious mental illnesses as feasible.
