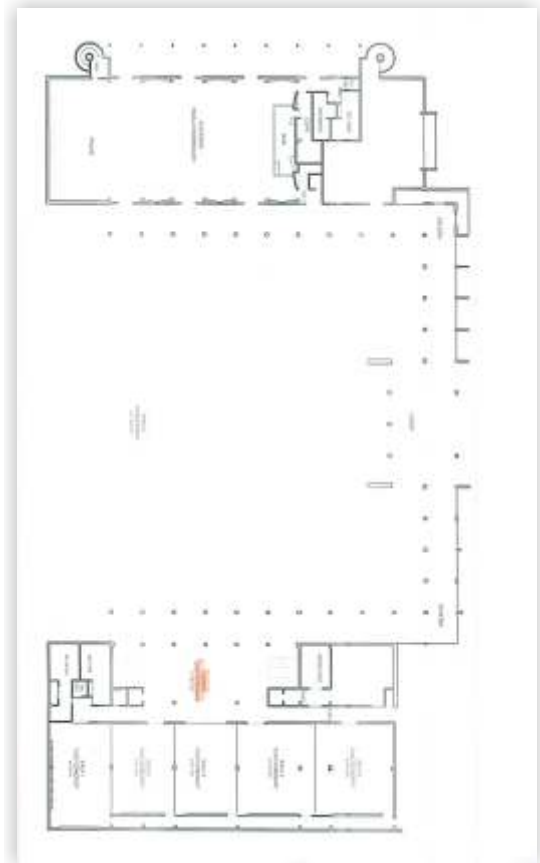
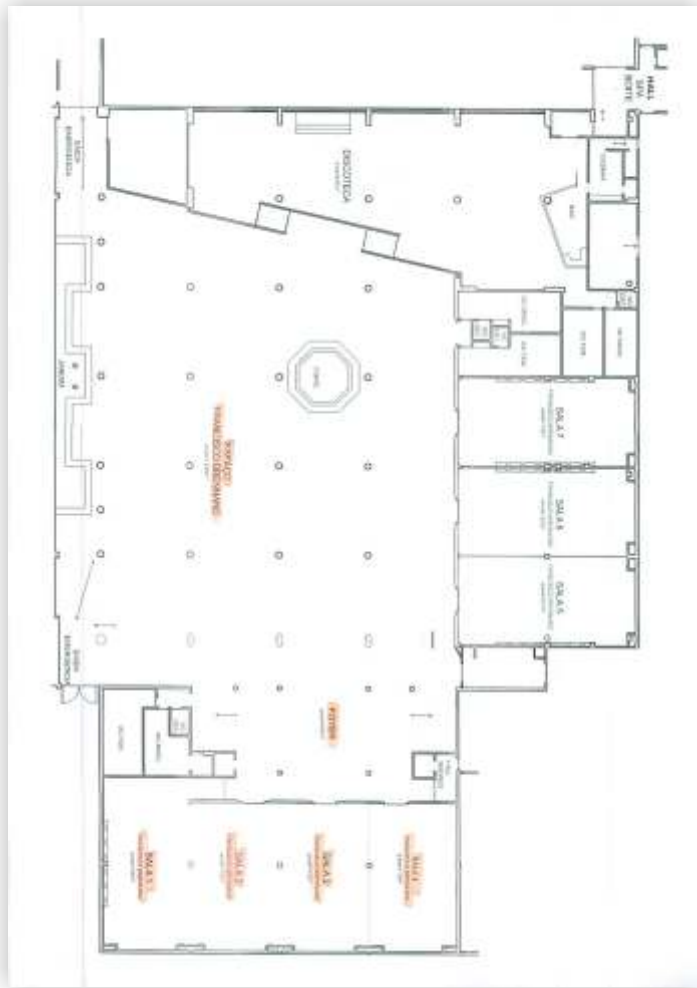
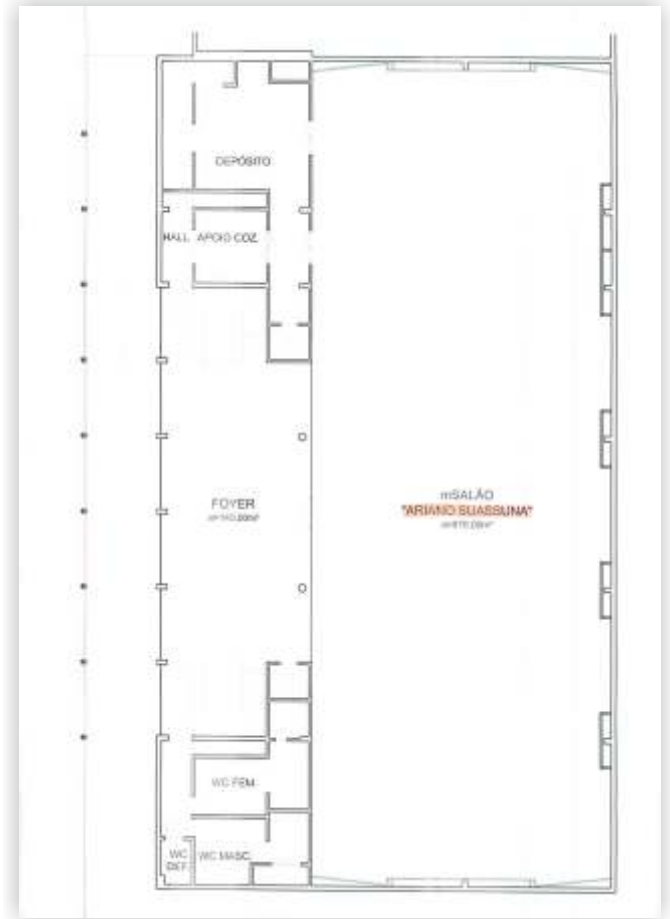

Description: The forms of selection and appointment of candidates for judges vary widely across the world, but in most countries, some kind of initial training is offered to successful candidates. This panel will present the general guidelines and minimum curriculum of initial training, based on the experience of each institute.

Training of new judges in Israel by the Institute of Advanced Judicial Studies is based on several elements: A general seminar, which teaches judicial skills, provides knowledge in several subjects and includes meetings with officials in the judicial system; seminars on specific issues relating to the various roles judges fulfill; periodic meetings with senior judges; and mentoring by experienced judges in the various courts. This review will focus on those elements in the training and will bring conclusions from the Israeli experience.

The New Zealand portion of this session will focus on the curriculum refreshment process, and the importance of contextual education in judicial skill building. As an example, the New Zealand presenters will refer to their intensive program for new judges.

Description: The United Nations Counter-Terrorism Committee (CTC) was established by Security Council resolution 1373 (2001) which was adopted unanimously on 28 September 2001 pursuant to Chapter VII of the UN. Security Council resolution 1373 (2001) requires all Member States to implement a number of measures intended to enhance their legal and institutional ability to counter terrorist activities at home, in their regions and around the world. The CTC is assisted by the Counter-Terrorism Executive Directorate which carries out the policy decisions of the Committee, conducts expert

assessments of each Member State and facilitates counter-terrorism technical assistance to countries. Two senior representatives of CTED and the IOJT will provide an overview of the criminal justice response to terrorism globally with a focus on trends and priority issue areas for national judiciaries and judicial academies.

John W.N. Tsekooko

Justice John Wilson Nattubu Tsekooko was called to the English Bar in July, 1968. Upon his return to Uganda from England, he was appointed a State Attorney in the Attorney General's Chambers, Directorate of Public Prosecutions, in December, 1968. He rose to the rank of Principal State Attorney. In December, 1974, he resigned and went into private practice. Apart from two years in exile in Kenya, (1977 - 1979) during the terrorising reign of General Idi Amin, he was in Private Practice and in Politics (1981 - 1985) until 1990 when he was appointed a Judge of the High Court. Justice John W. N. Tsekooko was appointed Judge of the High Court of Uganda in September, 1989 but took Judicial Oath on 23rd January, 1990. On July, 1994 he was appointed Justice of the Supreme Court of Uganda.

In May, 1997, Justice Tsekooko was appointed Chairman of the Uganda Judicial Education Committee which was the overall overseer of Judicial Education (training). In the same year (1997), he became Chairperson of the East African Judicial Education Committee whose role was to coordinate Judicial Education in the East African Community Partner States. About 1998, he was appointed by the Attorney General of Uganda to be Chairperson of the Management Committee of the Law Development Centre (LDC) which is a college training graduate lawyers who intend to practice law. He chaired the Committee for ten years, i.e., until 2007.

In 1999, he was appointed Chairman of the Law Council, a body which exercises control (including discipline) over all practicing lawyers in Uganda. On 31st January, 2013, he retired as Justice of the Supreme Court of Uganda and Chairperson JTC. However, on 31st July, 2013, he was appointed to work as Ag. Justice of the Supreme Court, for a term of two years.
