 - Technical assistance with data gathering and investigation to begin a statewide review and Washington State's current status with mental health services throughout the state and their collaboration with our court system.
 - Help with planning and holding a statewide summit.
 - We are a diverse state with urban courts that meet 1X/week all the way to JX with hundreds of judges – we need help organizing a summit on this issue that would provide meaningful.
 - We're looking to develop options for various jurisdictions. It would be helpful to have option resources like "if your jurisdiction X, then Y..."
 - Materials/technical assistance as we go forward to educate our judiciary.
 - A list of various states that have already begun to build or have completely built what is necessary for an intercept model. For instance – states with a 0 intercept program, states with diversion programs at intercept 3, along with a description regarding whether the court is unified, etc. Additionally, a list of possibly funding/grants. Also a roster of various statutory schemes that have been designed to get at the problem AOT, civil commitment, etc. so that we can look at what others have done – figure out who we might visit, etc. and not have to build blind.
 - Technical assistance. Group email to send information, queries and share programs.
 - The summit was great but I would like to know more about post-summit supports available.

- Where can we find \$, grants, other resource strategies? Have a prosecutor/state attorney to participate with/highlight how they can be part of the solution. Are there possible opportunities to partner with private groups in communities regarding housing, etc.?
- Every summit due to the schedule we always want to end early as people are trying to catch flights. Maybe we should have people plan to stay the day.
- Direct access to persons who can provide assistance, answer questions.
- Assistance with educating our legislators in the issues that underlie the need to implement the SIM model.
- Continued support via technical assistance for program implementation.
- Technical assistance as described in state exercises sheet.
- Technical assistance as discussed.
- Follow-up with our state via speakers and materials.
- (1) Much depends on law changes legislators are not knowledgeable in these areas, a lobbyist/testifier at the legislature; (2) more information on money issues and who pays for things. (speaker/moderator)
