## Court Structure

1. CA, IA, IL, MN, MO, WI – Single-tiered court or two-tiered court with exclusive felony and misdemeanor jurisdiction in the upper court.
2. AK, AR, CO, KY, MA, MI, NY, TX, VA – Two-tiered court with felony bindover and some felonies resolved in lower court. Misdemeanors filed and resolved in lower court.
3. PA – Two-tiered court with felony bindover and misdemeanor cases resolved in both upper and lower court.
4. AZ, FL, OR, UT, WA – Two-tiered court with exclusive felony jurisdiction in upper court and misdemeanor jurisdiction in lower court or direct felony filing in upper court and misdemeanor jurisdiction in lower court or exclusive felony jurisdiction in upper court and misdemeanors filed and resolved in both upper and lower court.

Note: GJ = General Jurisdiction, LJ = Limited Jurisdiction
