<u>Guide or the Prosecutors' Guide to Reducing Violence and Building Safer Communities</u>. These critical elements include community engagement, partnerships, technology, analytics and intelligence, training, tactics, resources, sustainability, and accountability.

The National Center for State
Courts, in partnership with Rulo
Strategies, launched the Rural
Justice Collaborative (RJC) to
showcase the strengths of rural
communities and highlight the
cross-sector collaboration that is a
hallmark of rural justice systems.

The work under the RJC is supported by a cross-sector advisory council composed of rural judges along with additional stakeholders in the justice, child welfare, and behavioral health systems. The advisory council guides and identifies innovative programs and practices.

HIGHLIGHTING THE WORK OF RURAL HEALTH DEPARTMENTS DURING NATIONAL PUBLIC HEALTH WEEK

Public Health AmeriCorps and NACCHO are working to support local health departments by increasing placements of AmeriCorps members into local health settings. This <u>initiative</u> aims to provide streamlined capacity building to local health departments while creating a pipeline of qualified public health professionals from AmeriCorps membership to full-time positions. COMMUNITY-BASED PREVENTION SYSTEM LINKED TO REDUCED HANDGUN CARRYING AMONG YOUTH GROWING UP IN RURAL AREAS

Firearm injury is now the leading cause of death among U.S. children and adolescents. As its toll grows, researchers have focused on stopping violence in the moments before it happens. But new research led by the University of Washington (UW) suggests that interventions made earlier in young people's lives may reduce the chances of it happening. The study, published April 6 in JAMA Network Open, found that UW's Communities That Care (CTC) prevention system reduced handgun carrying among adolescents growing up in rural areas.

BIOPSYCHOSOCIAL CONTEXTS OF TIMELY AND ADEQUATE PRENATAL CARE UTILIZATION AMONG WOMEN WITH CRIMINAL LEGAL INVOLVEMENT AND OPIOID USE DISORDER

Pregnant women with criminal legal involvement and opioid use disorder living in non-urban regions may be at risk for complex biomedical, psychological, and social barriers to prenatal care and healthy pregnancy. Yet, limited research has explored prenatal care utilization patterns among this subpopulation. This study describes the biopsychosocial factors of pregnant women with a history of criminal legal involvement and opioid use disorder associated with timely prenatal care initiation and adequate prenatal care utilization.

PREVALENCE OF SUBSTANCE ABUSE AMONG TRAUMA PATIENTS IN RURAL WEST VIRGINIA

Studies have shown that traumatic injuries are often associated with substance abuse; however, the patterns of substance abuse and the associated trauma mechanism have not been fully understood. In this <u>study</u>, researchers performed a cross-sectional retrospective analysis of adult trauma patients (motor vehicle, fall, assault, firearm suicide, brawl/rape, and machinery) hospitalized in two tertiary care hospitals in West Virginia between 2006 and 2016.

TELEHEALTH HELPS MORE PATIENTS WITH OPIOID USE DISORDER ACCESS BUPRENORPHINE TREATMENT

This <u>report</u> explores findings from a recent study showing that patients and providers benefitted from remote access to buprenorphine treatment. The study showed that allowing healthcare providers to prescribe buprenorphine—an FDA-approved medication for opioid use disorder (OUD)—remotely during the COVID-19 pandemic helped more patients start and stay in treatment without increasing overdose deaths.

PREVENTING, MITIGATING, AND RESPONDING TO VIOLENCE IN THE RURAL HOSPITAL SETTING

This <u>webinar</u> by the <u>Center for Optimizing Rural Health (CORH)</u> explores workplace violence and strategies for preventing, mitigating, and responding to violence in rural hospital settings.

Participants will:

- Develop an understanding of what constitutes an effective and compliant workplace violence prevention program;
- Learn mindsets and skillsets for intervening with high-risk patient populations, including those in the throes of a substance use disorder, chronic alcohol use, and untreated mental illness; and
- Describe the elements of a healthcare worker's personal protection plan, critical when violence emerges in the healthcare workplace.

WIDER ACCESS TO NARCAN HELPS RURAL COMMUNITIES FIGHT OVERDOSE DEATHS
