WHO: Conducted by GBA Strategies
WHEN: November 13-17, 2018
POLLED: 1,000 Registered Voters
STATS: MOE +/- 3.1% 19 times out of 20

THE STATE OF STATE COURTS





Confidence in state courts is the highest since the start of the State of the **State Courts series** though there is still plenty of room for improvement.



Views on cash bail are fluid, but after hearing messages for reforming the system, the public strongly believes that judges should base pretrial release decisions on factors other than ability to pay.

THE STATE OF STATE COURTS

KEY FINDINGS



A majority say they are unprepared to represent themselves in court yet alternatives to hiring a lawyer are only modestly popular.

Certain case types lend themselves to **Online Dispute Resolution (ODR)** while others may not, and the public sees pros and cons to ODR generally.



Confidence in state courts is at a seven-year high, which may (or may not) be connected to positive views of the economy.


THE STATE OF STATE COURTS

Q: "How much confidence you, yourself, have in the [STATE] court system—a great deal of confidence, some confidence, not very much confidence, or no confidence at all" and "How would you rate the economy in [STATE] today—excellent, good, just fair or poor?"

Increased confidence translates into higher marks on public trust attributes.

The perception that judges are out of touch with community concerns has moderated.



THE STATE OF STATE COURTS

Q: *"Which of the following statements comes closer to* your view?"




And there is across the board support to allow judges to use criteria other than money in making pretrial release decisions.

Statement 1


"I am confident I could find the information and tools I need to effectively represent myself if I needed to go to court to resolve a dispute."




1 in 5 respondents indicated they have represented themselves before the courts.
