**SECURITY ORDER**

In order to ensure proper decorum in the courthouses and courtrooms at all times during the above case, it is this 4th day of September, 2009, by the Circuit Court for Baltimore City,

**ORDERED** as follows:

1. The deputy sheriffs assigned to Courtroom 230 East for these proceedings shall establish limited, reserved seating in the courtroom for authorized media, and the litigants.
2. All persons attending this trial shall be subjected to security screening of their persons and belongings at the entrances to the Courthouse. Press credentials do not exempt members of the media from screening for security purposes.
3. Appropriate press credential identification cards will be made available to a limited number of members of the media for purpose of attendance at trial. Media members should pick up their press credentials from the Administrative office at room 200, Courthouse East, no earlier than 48

hours before and no later than 1 hour before the first day of trial. Press credentials shall be returned to the Media Liaison at the end of the trial.

4. The deputy sheriffs shall monitor the Courtroom at all times and they are authorized to remove anyone who violates this Security Order, the Media Protocol Order dated September 3, 2009, or at the instruction of the Court. Press credentials will be rescinded from members of the media who violate these orders. All violators shall be referred to the Court for appropriate sanctions.
5. The deputy sheriffs shall be present in the Courtroom and assist the Courtroom Clerk assigned to Courtroom 230 East whenever trial evidence is displayed there pursuant to the terms of the Media Protocol Order dated September 3, 2009.
6. No one shall be permitted to enter Courtroom 230 or remain therein during these proceedings who is wearing any item on his or her person or exhibiting any sign which, in the opinion of the Court, may tend to influence any juror or affect the orderly administration of these proceedings.
7. The deputy sheriffs shall not permit any demonstration inside the Courthouse. No one attending this hearing shall be permitted to congregate outside the Courtroom (within fifty feet of the entrance) during the course of this trial. Offenders shall be removed from the Courthouse.

8. Use of cellular telephones is prohibited within 100 feet of Courtroom 230. All cellular phones, pagers, PDA's, etc., must be turned off during court proceedings.
9. The deputy sheriffs shall escort the members of the jury from the Courthouse at the conclusion of trial each day and shall provide the jurors with information on available downtown escort services beyond the Courthouse. The deputy sheriffs shall apprehend anyone attempting to interfere with the members of the jury and refer them to the court for appropriate sanctions.
10. This Security Order is subject to modification by the Court at any time.
